REQUEST FOR EXPRESSION OF INTEREST FOR INDIVIDUAL CONSULTANCY SERVICES

EVALUATION COMMITTEE MEMBERS FOR THE SERBIA VENTURES PROGRAM

The Innovation Fund of the Republic of Serbia (IF) intends to engage **two experts** in the capacity of Evaluation Committee Members for the Serbia Ventures Program (Program) with extensive and hands-on experience in the venture capital industry. The Evaluation Committee will review and evaluate applications per guidance set forth in the Program Manual and select the most promising applicants in line with the available budget.

The individual consultants will be selected in accordance with the procedures set out in the IF's general Rulebook on procedures for selection of independent international experts for the purpose of implementation of the IF's financing programs (March 2017) and Internal procurement act (June 2020).

Interested and eligible individual consultants for the positions of Evaluation Committee Members for the Serbia Ventures Program should send expressions of interest, together with information on relevant experience and/or CV, in English language, to the contact information listed below.

Award criteria: (1) General work experience – up to 40 points, (2) Specific work experience – up to 60 points.

The IF reserves the right to request interview before concluding the evaluation and selection process. The date and time of these interviews will be confirmed or notified to the candidate at least 2 days in advance. If a candidate is prevented from attending an interview by force majeure, a mutually convenient alternative appointment is arranged with the candidate. If the candidate is unable to attend this second appointment, it will be eliminated from the evaluation process.

Selected candidates will be awarded contracts for individual consultancy services.

The maximum budget for this procedure is EUR 6.000,00 gross amount of total payments (ϵ 3.000,00 per Evaluation Committee Member contract including all costs, profits as well as any taxes and contributions that may be imposed in his/her country of residence and the IF).
